 - ANNUAL HOUSING ALLOWANCE RESOLUTION FOR SELF-EMPLOYED

WHEREAS Peace Lutheran Church, St. Louis, MO, a religious corporation, organized and existing by virtue of the laws of the State of Missouri, does, according to its Constitution and Bylaws, call certain workers for the fulfillment of its purposes and accordingly remunerate them for same, and, WHEREAS, the Internal Revenue Service Ruling 58.221, 1958-1 CB 53, including regulations and Special Rulings relative thereto provide for certain excludable allowances with reference to the treatment of housing and related costs of qualifying workers, provided that the election to do so are duly and timely adopted by the employing /calling body: NOW THEREFORE, BE IT RESOLVED, by the Church Council of Peace Lutheran Church, that a percentage of the salaries of the called workers of said church allocated to housing and expenses relative thereto be and are hereby set for the taxable year 2021 and not more than 100% of the respective total compensation.

WHEREAS Peace Voters' Assembly approved the Facility Enhancement Proposal on May 13, 2019, to reconfigure the former sanctuary and other spaces to better facilitate Early Childhood, Sunday School, VBS, Youth, Music and other ministries, and WHEREAS Peace Voters' Assembly (November 12, 2018) approved extending the existing Building For Tomorrow - Fulfilling Our Vision triennial pledge campaign (which was to expire 12/31/19) into 2019 and beyond (2021) to support and underwrite the venture proposed by the Facility Enhancement Committee, and

WHEREAS construction of the Facility Enhancement Project is now complete and all associated construction costs paid for, and WHEREAS bondholder debt has been fully extinguished; therefore,

BE IT RESOLVED that Peace Lutheran Church finds it appropriate to end the Building For Tomorrow - Fulfilling Our Vision triennial pledge campaign, as of the date this resolution is approved by Voters. Further, any contributions made by congregants to this campaign's building fund from that date forward will be applied to the General Fund.
